August 23rd, 2000 - This provision defines when a purchase or sale constitutes trading "on the basis of" material nonpublic information in insider trading cases brought under Section 10 b of the Act and Rule 10b 5 thereunder The law of insider trading is otherwise defined by judicial opinions construing Rule 10b 5 and Rule 10b5 1 does not modify the scope of insider trading law in any other respect
